ARTISAN/VENDOR AGREEMENT

This Artisan/Vendor Agreement ("Agreement") is made by and between Laurie-Sunrise Beach Rotary Club ("Rotary") having a mailing address of P. O. Box 98, Sunrise Beach, MO 65079; and Artisan/Vendor.

Rotary intends to arrange and produce an event known as the Pumpkin' Chunkin' Palooza ("Event") on Saturday, September 24, 2022. The Artisan/Vendor desires space on the Event grounds for the purpose of selling artwork/product during the Event.

In consideration of the following mutual covenants and promises and other good and valuable consideration, Rotary and Artisan/Vendor agree as follows:

1. **Quality.** All entries must be handcrafted items or festival appropriate items suitable for a family event.
2. **Space Size and Fee.** Single spaces are 10'x 10' maximum. You must furnish your own tables and chairs. No electricity can be provided and generators are prohibited. Your vehicle will be located in the parking area so please make proper arrangements to set up your booth.
It is highly recommended that you observe the weather forecast and come prepared for rain. (tarps, tents, etc.)
3. **Time.** On the day of the Event, setup is from 8:00 a.m. until 9:30 a.m. All artisans/vendors shall be set up by 9:30 a.m. Please check in at the ticket booth when you arrive and plan to have your display set up and your vehicle moved to the designated parking areas by 9:30 a.m.
4. **Taxes.** You are obligated to collect Missouri Sales Tax on sales and will be responsible for paying your own individual sales tax to the state.
5. **Cleanup.** Help us clean up the Event Area after the event by cleaning your area and the area around your booth. Please have all items removed from the Event Area by 6:00 p.m.
6. **Inclement Weather.** It is highly recommended that you observe the weather forecast and come prepared if necessary. If there is a threat of a major storm, please stay tuned to the Event's Facebook page for updates.
